Article I

The name of the limited liability company is:

Article II

Unless the articles of organization otherwise provide, all limited liability companies formed pursuant to 1993 PA 23 have the purpose of engaging in any activity within the purposes for which a limited liability company may be formed under the Limited Liability Company Act of Michigan. The purpose of this company is to provide in-home care services. These services may include:

- Assistance with activities of daily living and personal care such as feeding, bathing, toileting, dressing, ambulation and transferring - Assistance with instrumental activities of daily living, such as light housekeeping, laundry, grocery shopping, errands, meal preparation,

medication reminders and companionship

- Personal assistant services which includes any hands-on assistance, incontinent care, and bathing

- Companionship services which may include social outings, playing cards, visiting and conversation, reading books, activities and hobbies, recreational activities, and other social activities.

All in-home services will be performed by Certified nurses aids (CNAs). As a non-medical home care agency, the company will not engage in, nor contract with others, to provide the practice of medicine.
