IF, AFTER THE FILING OF THESE ARTICLES OF ORGANIZATION, THE MICHIGAN ACT IS AMENDED TO AUTHORIZE ACTION FURTHER ELIMINA

TING OR LIMITING THE PERSONAL LIABILITY OF MANAGERS OF LIMITED LIABILITY COMPANIES, THE LIABILITY OF A MANAGER OF THIS LIMITED LIABILITY COMPANY SHALL BE ELIMINATED OR LIMITED TO THE FULLEST EXTENT PERMITTED BY THE MICHIGAN ACT, AS SO AMENDED. ANY REPEAL, MODIFICATION OR ADOPTION OF ANY PROVISION IN THESE ARTICLES OF ORGANIZATION INCONSISTENT WITH THIS ARTICLE SHALL NOT ADVERSELY AFFECT ANY RIGHT OR PROTECTION OF A MANAGER OF THE LIMITED LIABILITY COMPANY EXISTING AT THE TIME OF SUCH REPEAL, MODIFICATION OR ADOPTION.
