NO MANAGER OF THE LIMITED LIABILITY COMPANY SHALL BE PERSONALLY LIABLE TO THE LIMITED LIABILITY COMPANY OR ITS MEMBERS FOR ANY BREACH OF ANY DUTY ESTABLISHED PURSUANT TO SECTION 404 OF THE MICHIGAN ACT; PROVIDED, HOWEVER, THAT THIS ARTICLE SHALL NOT ELIMINATE OR LIMIT THE LIABILITY OF A MANAGER FOR ANY OF THE FOLLOWING:

- (I) THE RECEIPT OF A FINANCIAL BENEFIT TO WHICH SUCH MANAGER IS NOT ENTITLED;
- (II) LIABILITY UNDER SECTION 308 OF THE MICHIGAN ACT; OR
- (III) A KNOWING VIOLATION OF LAW.
- (IV) AN ACT OR OMISSION OCCURRING BEFORE THE DATE WHEN THE PROVISION BECOMES EFFECTIVE.

IF, AFTER THE FILING OF THESE ARTICLES OF ORGANIZATION, THE MICHIGAN ACT IS AMENDED TO AUTHORIZE ACTION FURTHER ELIMINA

TING OR LIMITING THE PERSONAL LIABILITY OF MANAGERS OF LIMITED LIABILITY COMPANIES, THE LIABILITY OF A MANAGER OF THIS LIMITED LIABILITY COMPANY SHALL BE ELIMINATED OR LIMITED TO THE FULLEST EXTENT PERMITTED BY THE MICHIGAN ACT, AS SO AMENDED. ANY REPEAL, MODIFICATION OR ADOPTION OF ANY PROVISION IN THESE ARTICLES OF ORGANIZATION INCONSISTENT WITH THIS ARTICLE SHALL NOT ADVERSELY AFFECT ANY RIGHT OR PROTECTION OF A MANAGER OF THE LIMITED LIABILITY COMPANY EXISTING AT THE TIME OF SUCH REPEAL, MODIFICATION OR ADOPTION.
