CONSTITUTION

ARTICLE I

ASSOCIATION OF MEMBERS

Section 1. TITLE This Association shall be known as the PULASKI CIVIC CLUB OF ECORSE, a Michigan non-profit Corporation, hereinafter referred to as "Association" or "Club".

Section 2. PURPOSE The objective of this Association is to make the City of Ecorse, Michigan, as desirable as possible for residence, business, charitable and political purposes. To increase the convenience, safety, health, education, or pleasure of the inhabitants, or improvement of general benefit to the City of Ecorse as the judgment of the Association may direct. To provide social activities for the benefit and enjoyment of the members and their families.
